

By this application, the applicants - Builders seek modification in para 3 of the order dated 3rd October, 2007, whereby, the condition has been imposed on the applicants that the price of five plots belonging to the builders - applicants shall remain with the Registrar of this Court till the final decision of the criminal case pending against the builders.

2. It has been contended ^{by} ~~the~~ Syed Zulfiqar Ali Bukhari, learned counsel for the applicants that the entire money has been deposited by the CDA with the Registrar of this Court and many affectees have collected their shares, but the applicants - Builders are being declined the payment mainly because of the said condition. He further contended that the criminal case against the appellants - builders will take sufficient time for its disposal. In view of above, we deem it appropriate that condition be
